

ALTERNATIVE SERVICES:

The following charges for direct burial and direct cremation do not include additional items of service, merchandise, facility use and livery that the customer may wish to select.

Federal Trade Commission (FTC) Disclosure

Our charge for a direct cremation (without ceremony) includes: basic services of funeral director and staff; a proportionate share of overhead costs; removal of remains; transportation to crematory; necessary authorizations; and cremation if relevant.

If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like cardboard or composition board (with or without and outside covering). The containers we provide are a cardboard container or an unfinished wood box.

New York State Disclosure

If you want to arrange a direct cremation, you may use an unfinished wooden box or an alternative container. Alternative containers can be made of heavy cardboard, pressed wood or composition materials (with or without an outside covering), or may be pouches of canvas or other materials.

Direct Cremation includes the local transfer of remains to the funeral home, the services of the funeral director and staff, securing of necessary authorizations, local transportation by livery to the crematory, an alternative container for cremation and the return of the cremated remains to the funeral home.

We offer a selection of four alternative containers, including containers made of wood, containers made of cardboard, and containers made of other composite materials.

- Direct Cremation with a cremation container supplied by the purchaser. (All such containers must meet any state or crematory requirements.) \$ 1800.00
- Direct Cremation with a Cardboard Alternative Container, Unstained exterior, No interior \$ 1500.00
- Direct Cremation with a Cardboard Elderlite Container, Gray exterior, Crepe interior \$ 2800.00
- Direct Cremation with a Poplar Alternative Container, Polished Walnut exterior, Crepe interior \$ 3800.00

The direct cremation prices do not include the crematory charge.

DIRECT BURIAL / IMMEDIATE BURIAL:

Our charge for an immediate burial (without ceremony) includes: basic services of funeral director and staff; a proportionate share of overhead costs; removal of remains; and local transportation to cemetery.

The first package includes the local transfer of remains to the funeral home, the services of the funeral director and staff, securing of necessary authorizations, basic local transportation by livery to the cemetery **and an alternative container.** \$ 2680.00

If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

New York State Disclosure

In New York State, embalming is not required by law. If you do not want embalming, you have the right to choose an arrangement which does not require you to pay for embalming such as direct cremation or direct burial. If you select certain funeral arrangements such as viewing or an open casket funeral, embalming may be required by the funeral firm.
